# 3. Restorative Phase:

- Use of restorative materials (crowns, veneers) to correct any residual esthetic issues post-orthodontic treatment.
- o Considerations for occlusal adjustments.

### **Data Collection:**

Patient records, clinical photographs, radiographs, and periodontal charts were collected pre- and post-treatment to assess the improvement. Patient satisfaction surveys were conducted post-treatment.
